Each competitor will be responsible for any injury that may be occasioned to any person or animal or damage to any property while on the grounds by any horse owned or in his/her custody, or control, and shall indemnify and hold harmless the Tri-County Riders, its officials and directors individually and collectively, and corresponding organizations, clubs, and arena owners, if any, from and against all charges and expenses of every kind and nature whatsoever arising out of or which may be incurred by reason of any accident, injury or damage to person or property caused by the ownership completion or custody or control of any animal competitor. By signing this agreement you shall be deemed a riding member of Tri-County Riders for the entire show season for any subsequent Tri-County Riders function in which you or your child may participate. In signing this release, please bear in mind that when riding horses that there is a certain element of danger involved and that you will be riding at your own risk. Also all riders under the age of 18 MUST wear a helmet at all times while mounted. This is a Tri-County Riders rule. Adults who choose not to wear a helmet do this at their own risk. Signing this release also releases Tri-County Riders of all liability if a adult chooses not to wear a helmet. Minors Must Have Form SIGNED BY PARENT/LEGAL GUARDIAN. NO EXCEPTIONS.
